### **CELEBRATING OUR JOB CREATION SUCCESSES**

The ASISA Academy offers two graduate internships: the Investment Management Administration & Client Services (IMACS@TSiBA) Internship and the Independent Financial Adviser (IFA) Internship. More than 80% of our interns are permanently hired on completion of their internships and are now building successful careers in our industry. Every year in November, we celebrate their successes at our annual ASISA Academy internship alumni event held in Cape Town and Johannesburg.

The guest speaker at the Cape Town event was Aron Samuels, one of the interns who participated in our inaugural IFA internship in 2016. Now a qualified financial planner, Aron is also the founder of The Wealth Coach.

In Johannesburg, the guest speaker was Palesa Dube, Director and Wealth Manager at Wealth Creed. Wealth Creed was a beneficiary of the ASISA IFA Development Programme, and Palesa also won the IFA Financial Planner of the Year Award for 2022.

## **SKILLS DEVELOPMENT UPDATES**

#### **Financial Markets Practitioner Learnership**

We have had a fantastic response from employers who have enrolled 22 employees in our second instalment of the <u>Financial Markets Practitioner (FMP) Learnership</u>. This Fasset-registered NQF Level 7 learnership provides a learning pathway to a higher qualification, such as an honours degree or a NQF level 8 post graduate diploma. The learnership also qualifies for categories B and D on the B-BBEE Learning Programme Matrix for scoring skills development points.

The 14 delegates participating in our current FMP Learnership will conclude their classroom sessions in February 2023 and write their external exam the following month. The blend of classroom sessions spaced over a year of full-time work enables delegates to integrate their new knowledge with practical workplace experiences.

#### UCT Life Insurance Claims Assessors Short Course

The 2022 <u>UCT Life Insurance Claims Assessors Short Course</u> concluded in October and the 19 delegates wrote their final three-hour exam in November.

This course has gone from strength to strength over the past few years and was oversubscribed in 2022. We have therefore decided to deliver it twice in 2023. The course starting in March is already fully subscribed! Please click <u>here</u> to enrol in the second course starting in July 2023.

#### **UCT CIS & IMACS Short Courses**

In November, the <u>UCT Investment Management Administration & Client Servicing (IMACS)</u> <u>Short Course</u> was delivered twice in Cape Town: as a bespoke course for Intembeko Investment Administrators employees and as a public course.

Another Academy course that has performed exceptionally well since its inception is the <u>UCT</u> <u>Collective Investment Schemes (CIS) Short Course</u>, which saw its fifth delivery for the year in November, this time as a bespoke course for First National Bank (FNB) employees.

Intembeko and FNB have already committed more employees to another four UCT Short Courses to be delivered in December 2022 and early in 2023.

#### **Online Sprints**

Our two-hour interactive online Sprints cover a wide range of investment-related and Consumer Financial Literacy (CFE) topics. In addition to the public Sprints scheduled throughout the year, the ASISA Academy can also deliver any combination of these Sprints as bespoke in-house courses.

# **RETIREMENT FUND TRUSTEE EDUCATION**

In November, we presented seven public <u>Retirement Fund Trustee Education</u> (RFTE) workshops and three bespoke workshops to more than 90 trustees and principal officers. The following retirement funds had requested bespoke workshops:

- Securities Employee National Provident Fund (SENPF) Fund Annual Financial Statement Analysis workshop
- PetroSA Fund Annual Financial Statement Analysis workshop
- Assmang Provident Fund Death Benefits workshop

The ASISA Academy RFTE workshops are funded by the ASISA Foundation from generous donations made by ASISA members. The workshops are professionally recognised for CPD points by Batseta - Council of Retirement Funds for South Africa.

We recently added a new workshop to our comprehensive line-up. The RFTE <u>CRISA 2</u> workshop provides delegates with an understanding of the principles of the Second Code for Responsible Investing in South Africa, 2022 (CRISA 2), which builds on the first CRISA Code issued in 2011. Launched in September 2022, CRISA 2 contains five voluntary principles for stewardship and responsible investment as a key component of the South African governance framework.



## **NEW IN 2023**

At the Academy we continually develop new courses in response to industry needs. In March 2023 we will be presenting our inaugural ASISA Academy <u>Compliance Masterclass</u>, developed for experienced compliance professionals interested in sharpening their skills.
