Held on Tuesday, 26 January, the graduation ceremony celebrated and acknowledged delegates who successfully completed the following [courses and internships](#) in 2020:

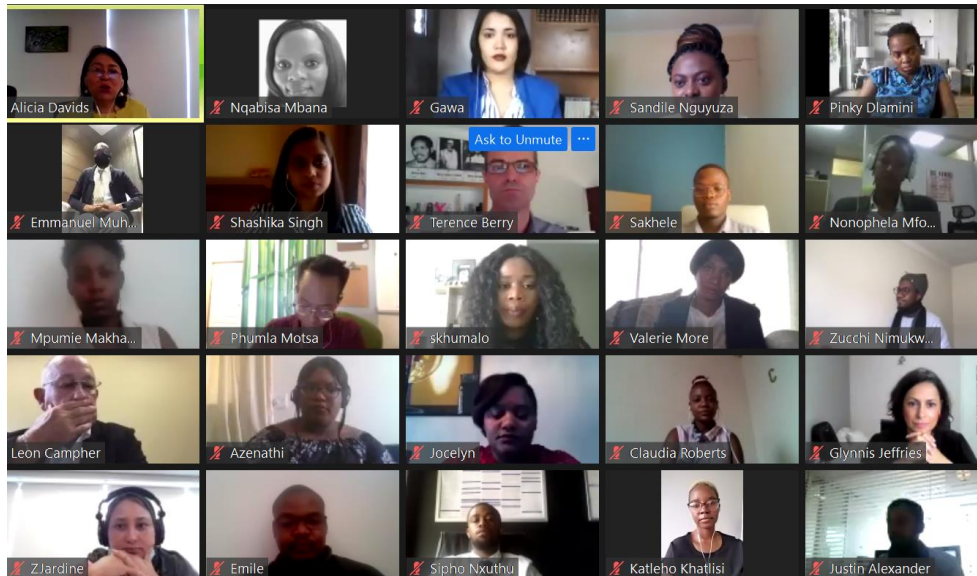
- The UCT endorsed [Collective Investment Schemes \(CIS\) Short Course](#);

We were privileged to have Nerina Visser, Director of etfSA Portfolio Management and President of the CFA Society South Africa, as the guest speaker. No stranger to our courses, Nerina is passionate about education and empowering people through knowledge.

She reminded our graduating delegates that honesty and integrity are the cornerstones of being a financial services professional. She therefore called on all financial services professionals to continuously hone their ability to discern between real and fake and to be "truthful and honest and have integrity".

Nerina also compared the graduating delegates to diamonds that have reached their point of being valuable as a result of an ongoing journey of learning, which she likened to the process of cutting and polishing a diamond. She also reminded delegates that a diamond only shines if all its many facets are visible.

Nerina left the delegates with the following words of encouragement: "For you to really be a diamond of value and sparkle in the workplace you need to bring all of the facets that make you the diamond into the work place. ### **Wanted: opportunities for work ready interns**

The difficult operating environment created by Covid-19 has resulted in a critical shortage of available internship opportunities in the financial services industry. At the same time the ASISA Academy received a record number of applications from black graduates for the limited internships on offer for 2021.

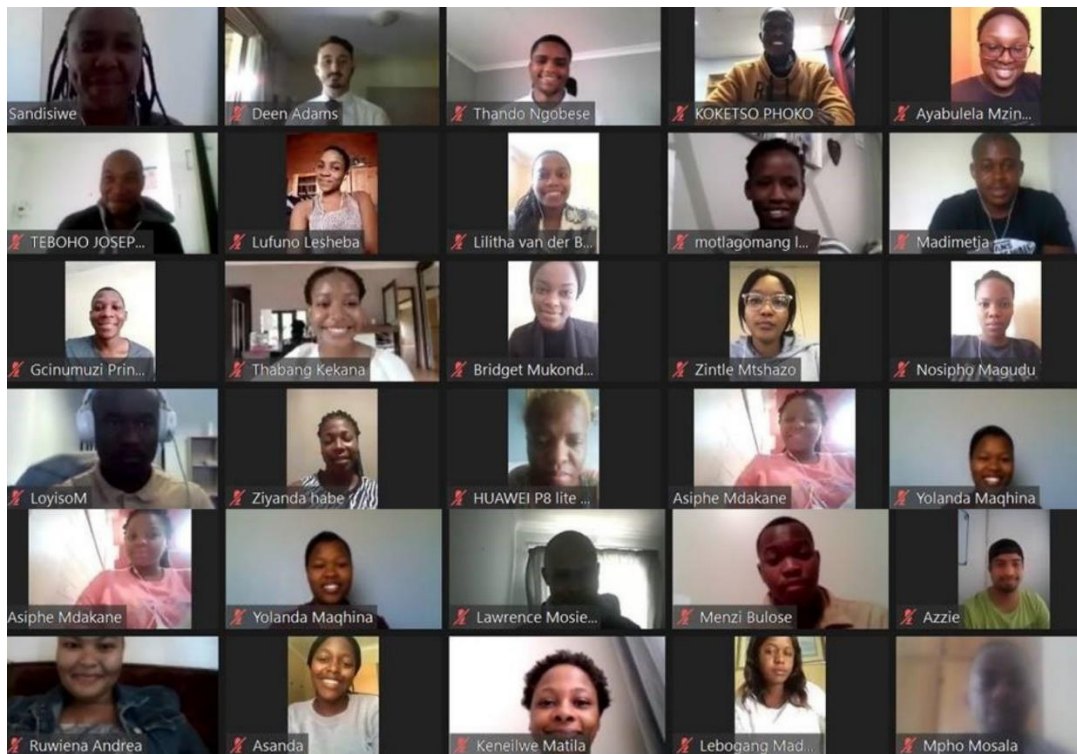
In an attempt to help the enthusiastic graduates who were not able to secure internships for this year, the ASISA Academy funded and delivered an online work readiness course over eight mornings in January. The intention was to provide these new job seekers with an extra set of skills and knowledge that will hopefully lead to opportunities and facilitate a smooth transition for the intern as they enter a workplace. Attended by 53 graduates, the course covered the following topics:

- **Industry knowledge:** Introduction to the Financial Services Industry, Introduction to Investments, Introduction to Life Cover, and "A day in the life of an Independent Financial Adviser"
- **Relevant legislation and regulation:** The Financial Intelligence Centre Act (FICA), the Financial Advisory and Intermediary Services Act (FAIS) and Treating Customers Fairly (TCF)
- **World of Work skills:** Office Etiquette, Effective Communication, Conflict Management, Teamwork, Time Management, Ethics and Professionalism, Cultural Diversity, Health and Wellbeing, Dealing with failure and building resilience, Presentation Skills, Setting Goals, Action Planning, Personal Finance, Networking and Career Management, CV Writing and Interview Tips

The graduates who successfully completed the work readiness course were rewarded with an ASISA Academy certificate of completion. The graduates hoping for internship opportunities have achieved a range of degrees ranging from BCom Finance and Investments to BCom Investment Management and Bachelor of Law with Specialisation in Financial Planning Law. The wide variety of degrees were obtained from the spectrum of South African universities, including the University of Cape Town, University of the Free State, University of Johannesburg, University of KwaZulu-Natal, Monash University, University of Pretoria, Rhodes University and TSIBA Business School.
